Purpose and legal basis for processing

The personal data are managed in accordance with the principles of transparency, lawfulness and fairness for discharging the obligations resulting from the outstanding pre-contractual contract/agreement and the related administrative and fiscal procedures, and for the relationship activities with customers which are necessary to perform the contractual/pre-contractual relationship.

Recipients of personal data

- Freelancers in the legal and commercial field
- Managers of the information system

Obligation/Right to provide your personal data

The provision of personal data is mandatory for the management of contractual/pre-contractual reports and consequently their failure or incomplete supply will not allow the establishment of contractual relationships.

Data retention period

Your personal data will be preserved for as long as your contractual relationship exists and for the expected duration by legal obligations.

Rights of the data subject

You may ask the Data controller to access at your personal data, rectification, cancellation of the same, limitation or opposition to processing as well as data portability.

Right to propose a complaint to the Supervisory Authority

If you believe that the processing of data concerning you is in violation of Regulation 679/2016, you may submit a complaint to the Guarantor for the protection of personal data.

Transfer of personal data in extra EU Country

The information held by the Data controller may be transferred abroad to E.G.O. ELEKTRO-GERATE AG based in Zug Baarerstrasse 8 (Switzerland). Switzerland is a state in which the European Commission has stated that the level of data protection is at an appropriate level and therefore personal data can be transferred.
